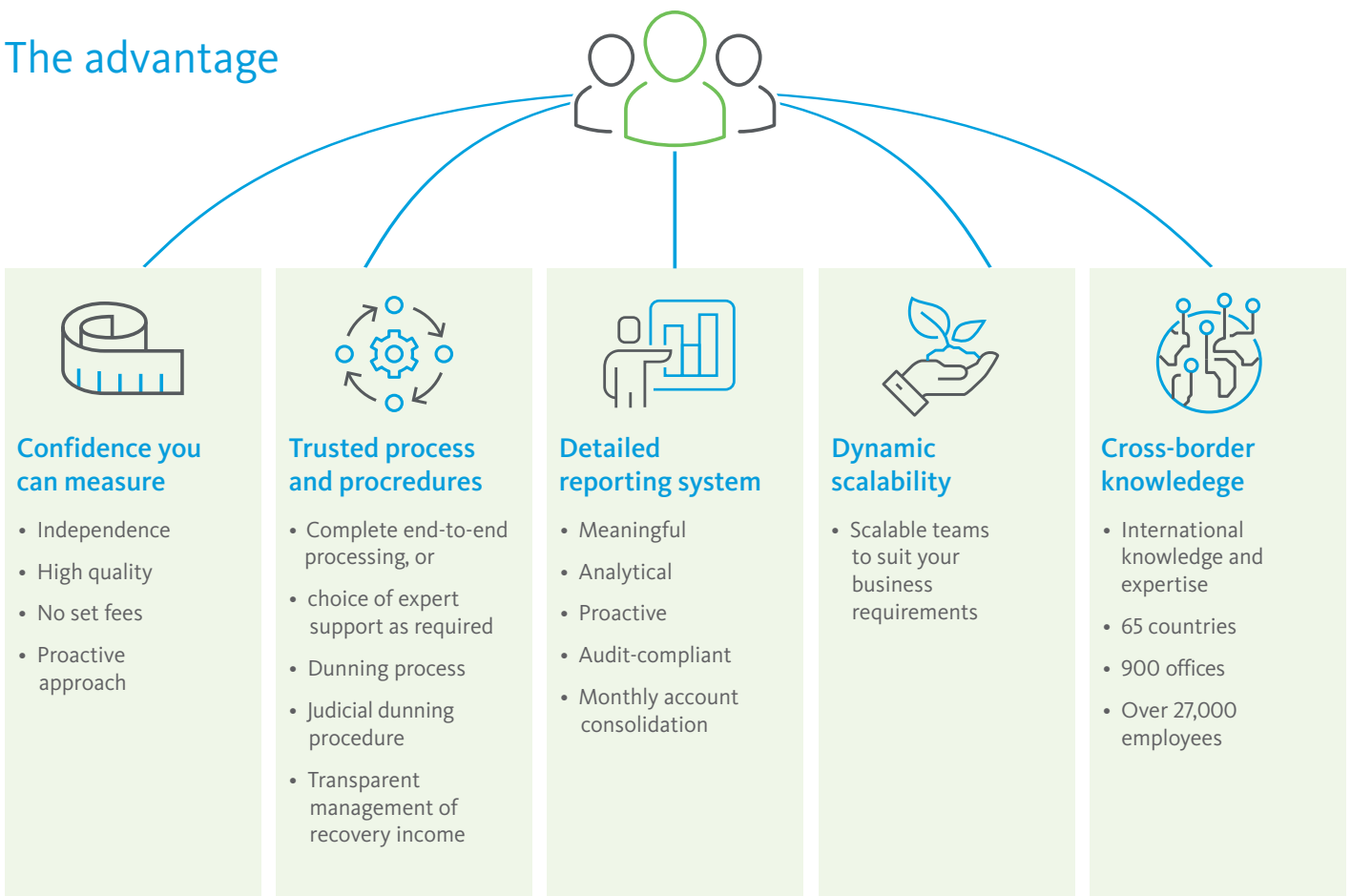
# The solution
