Accident and health defined:

U.S. - Accident and health insurance is a broad term that covers specialty policies available through an employer or carrier. It is coverage that pays benefits in case of sickness, accidental injury or accidental death. If it's in connection with a loan, it may also pay for loss of income or for debt payment.

International - Accident and health refers to benefits through a wide range of covers, including group and individual disability, personal accident, travel insurance, medical expenses, medical assistance, critical illness, death and disability. Accident and health also encompass aviation personal accident, war risks, kidnap and ransom insurance and sport accident insurance.
